The person should, however, realize that both the cause of their reactions and the emotional distress are transient. In addition, by effectively listening to the man, a trauma counselor can offer assistance. The other duty of the crisis therapist includes improving coping

strategies in the client. In an individual, coping abilities are built by presenting the person with potential alternatives to his dilemma, incorporating technicalities to alleviate tension and fostering affirmative thought.

The Sandy Hook Elementary School Problem

The problem in concern was the shooting that occurred on 14th December, 2012, at the Sandy Hook Elementary School which is located in Connecticut. The perpetrators, the distressed Adam Lanza had already shot his mother before he went to short the students and teachers at his school. He was also involved in the shooting of the support stuff in the school. After massive shooting which killed many people in the school, he went ahead and shot himself. The survivors of the shooting include a young girl who assisted in the description of the perpetrator as an angry man. Due tot eh horror, the young girl required a crisis counsellor.

Crisis Intervention Model

In regard to the Crisis Intervention Model, Robert explains seven major stages that constitute the crisis intervention model that could be ideally used to the help the girl who had witnessed the mass shooting at the school. To begin the procedure, the counselor should conducts a rigorous biopsychosocial assessment of the girl. Facially, the procedure is supposed to invoke the medical needs, stressors and backings, as wells the solution in the outer and inner assets and adaptive systems. The next step in the model is to establish a fast and compatible collective partnership with the girl. In addition, the crisis counselor should recognize the crisis precipitants, who involve schools and men in this situation. To these precipitants, the girl will show multiple thoughts and concerns that the psychologist should be able to cope with. The crisis counselor offers

options, as the girl still runs screaming at the sight of police officers and declines to advance in her studies. These alternatives can include suggesting private tutoring at home but not implying that not all men with a pistol are killed because others defend those police officers. The final step is to conduct a follow up to make sure that the client recovers from trauma and leads a normal life once again.
